YEAR K- 2 ACCEPTABLE USE AGREEMENT

15 February 2024

Dear Parents/Carers,

To develop a responsible attitude when using ICT and electronic equipment and to keep up to date with changing technology, we would ask all parents/carers and students to read and sign our ICT agreement.

This agreement is a promise, on behalf of the student, to behave appropriately, courteously and cooperatively in all situations when using ICT electronic equipment. Teachers will discuss the rules outlined but we would appreciate your support in also discussing them with your child. Students and parents are required to sign the agreement and return it to their class teachers.

The students will only be permitted to use the ICT equipment in the school once this agreement has been signed and returned.

Please note that while every reasonable effort is made by schools and the Department of Education to prevent student exposure to inappropriate online content, while using the Department's online services, it is not possible to completely eliminate the risk of such exposure. The Department cannot filter internet content accessed by your child at home or in locations away from school. The Department recommends that parents monitor their child's use of technology and keep communication open with your child to ensure your child knows to tell a trusted adult if they see something that scares them or is inappropriate on the internet.

Years K-2 Code of Behaviour

- I will keep all food and drink away from the chromebook/laptop/iPads/smart board
